TERMS AND CONDITIONS OF MEMBERSHIP		
<ol style="list-style-type: none"> <li>1. Members should be in good medical health at the time of joining.</li> <li>2. Membership is <u>FREE</u> but you must at least pay your first month premium to qualify for immediate benefits.</li> <li>3. Members are allowed to pay monthly premiums in advance and in excess of the \$3000.00 benefit.</li> <li>4. The total accumulated payment made on a member's account, when in excess of the society benefit of \$3000.00, will be applied in full to their invoice.</li> <li>5. In instances where members default on the payment of their monthly premiums for a period of less than the last three months, the relatives are given the opportunity to pay the outstanding sum in order for the deceased member to qualify for and receive the benefits due.</li> <li>6. In instances where members default on the payment of their monthly premiums for a period of more than three months but less than a year, they will not be eligible for the benefit but granted full reimbursement of the sum paid.</li> <li>7. Any default on payment of the monthly premium in excess of a year will result in forfeiture of benefits but 75% of the sum paid will be reimbursed.</li> <li>8. Members do not earn interest on the funds paid into the burial society and will only be refunded the amount paid.</li> <li>9. Members would be provided with, and if they are not, should demand a receipt for their payment.</li> <li>10. Membership is not transferrable.</li> <li>11. Members whose death occur overseas and have not been repatriated to Grenada would not be eligible for benefit.</li> <li>12. Persons can only join the society once.</li> <li>13. Should a member decide to cancel his membership in the burial society, Otway/ Bailey will not obligated to refund any monies paid.</li> </ol>
